I attended the 209<sup>th</sup> Central Atlantic RSC on June 19, 2021 via Zoom.

You will also find a full list of deadlines for the upcoming Conference Agenda Report and Conference Approval Track. The decision on whether to hold the World Convention scheduled for 2022 in Melbourne, Australia will be made in October of this year.
